| AGREEMENT TO PARK RULES AND REGULATIONS | | | | |

| You are responsible for any injury or damage caused by you or your dog(s) outside of normal play. | | | | |
| You must be present at all times and keep your dog(s) in sight and under control. | | | | |
| Poop: Clean up after your dog! No exceptions! | | | | |
| Do not let anyone other than your own people guests through the member gate at any time, regardless of whether the people wanting in have a dog with them or not, or if they say they are a member or not. Disregard of this rule may result in termination of your membership. | | | | |

| Dogs must be on leash to and from the park access points. Carry a leash with you in the park in case you have to move your dog. |

| No bullies! Rough play is fine as long as it is consensual. Rough play and chasing are not acceptable if any of th dogs involved are not comfortable with the situation. Just because a dog's intent is to play does not make the dog's behavior acceptable if the other dog is not enjoying itself. Mounting should be discouraged as it is generally not enjoyed by the dog being mounted. |
| Dogs with excessive barking may be asked to leave. Try to distract or re-direct your dog if barking persists. |
| Digging holes : Do not let your dog dig holes; make every effort to distract or re-direct your dog. Show respect for the park property. |
| Dogs must be up-to-date on shots . |
| For safety reasons, children under 16 years of age must be accompanied by an adult and must be closely supervised at all times. Children must not be allowed to run, scream, chase the dogs, or pet another person's dog withou first getting that person's permission. |
| Dogs in heat are not allowed in the park at that time. |
| If your dog shows aggressive behavior, take immediate action: move your dog to another area of the park, leave the park, or do whatever you have to do to prevent the behavior from reoccurring (time-out, redirect behavior, etc.). Talk with other owners involved to make sure that all dogs are OK. |
| Dog fights. Some experts recommend the following method for breaking up a dog fight: each owner grabs his/he dog by the hindquarters or tail, pulls the dog away from the other dog, and holds onto the dog until it calms down. Even this method is not risk-free. |
| Only flat-buckle collars or harnesses should be worn by dogs in the off-leash part of the park. Pronged (pinch), spiked, studded and choke chain collars are not allowed in the off leash area of the park. |
| Dogs that are sick and dogs with external parasites (e.g. fleas) should not be in the park. |
| Agility equipment and the dock are to be used at one's own risk. |
| Food: Do not feed dog(s) in the park including dog bones, chew treats, etc. "One gulp" treats are permitted. |
| No more than 4 dogs per person are allowed in the Park. |

CONTRACT REGULATIONS

By signing this contract you, the Buyer(s), have purchased for your dog(s) a day-pass or a membership in Meadow Run Park. Buyer(s) agree(s) that the visit or membership fees are **non-refundable** unless Meadow Run Park is no longer able to provide a substantial number of the services offered when this contract was signed, in which case Buyer(s) will receive a prorated refund. Buyer(s) agree(s) that the day-pass or membership is **not transferable** to another dog owner. Other dogs owned by the Buyer(s) may be substituted for those named above provided they are approved of by Meadow Run Park management. **Additional dogs** owned by the Buyer(s) may be added to those named above provided the dogs are approved of by Meadow Run Park management and the pro-rated difference in membership rate, if any, is paid. Buyer(s) may **cancel this contract** without penalty or obligation and receive a membership refund (minus the administrative fee) within 7 calendar days of the date membership begins. Meadow Run Park reserves the right to deny entry to the facility or membership in the facility for any reason, and to terminate membership or expel a person and/or dog from the facility for any reason. If Meadow Run Park terminates a membership, the corporation reserves the right to either return pro-rated fees or no fees.

RELEASE AND WAIVER OF LIABILITY AND ASSUMPTION OF RISK

Meadow Run Park, LLC has created this park for dogs and their owners and guests to enjoy together. I understand that the use of this park and other Meadow Run Park facilities means that I am taking certain risks of damage or injury to myself, my guest(s), my property, my dog(s) and to others in the park and associated facilities. Included in these risks are negligence on the part of Meadow Run, its owners, employees, customers and guests. I realize that when dogs are around strange people and other dogs or even just running around by themselves, some accident or injury may result, and that people, dogs and property might be injured or damaged.

Because I want to use and enjoy Meadow Run Park and its associated facilities, I hereby agree to assume these risks, for myself, my guest(s), my property, and my dog(s). I agree to make an inspection of Meadow Run Park property, and to continue to stay vigilant regarding the property and regarding my guest(s), my property, and my dog(s). I agree that it is solely my responsibility to determine whether the Meadow Run Park property itself and any particular situation involving other members, guests and dogs is safe for myself, my guest(s), my property, and my dog(s).

In exchange for the opportunity to use this facility, according to the Rules and Regulations, I hereby release and discharge Meadow Run Park, LLC, and its owners, members and employees from any and all liability, claims, demands, causes of action, loss, damage or injury to person or property, including negligence, breach of contract, breach of any statutory duty of care, or any death and serious injury which may result while I or my guest(s) or my dog(s) are on the Meadow Run Park premises.

I also agree to be responsible for my guest(s) and my dog(s) and for any liability caused by me, my guest(s) and my dog(s), and that I will hold harmless and indemnify Meadow Run Park, LLC, and its owners, members and employees from any and all liability, claims, demands, causes of action, loss, damage or injury to person or property, including any death and serious injury which may be caused by myself, my guest(s) or my dog(s) while they are on the Meadow Run Park premises.

Notwithstanding the foregoing, Meadow Run Park's maximum liability for any damages whatsoever arising out of the membership or use of the Park, regardless of the manner in which claimed or the form of action alleged, is limited to the amount paid to Meadow Run Park by the Buyer for an annual membership.

In no event shall Meadow Run Park be liable to the Buyer for, and the Buyer shall hold Meadow Run Park harmless from, any claims for lost profits, or incidental, indirect, punitive, exemplary, special or consequential damages.

I agree to waive, release and forever discharge any and all claims, whether known or unknown, that I now have or may have in the future against Meadow Run Park, LLC and covenant not to sue Meadow Run Park, LLC with respect to my use of the Meadow Run Park and its associated facilities.

I am 18 years old or older and have the legal capacity to enter into a binding contract. I intend for this release to be binding upon my heirs, beneficiaries, next of kin, personal representative or executor, and assignees.

I have read, understand, and agree to abide by all of the Rules and Regulations, Contract Regulations, and the Release and Waiver Liability and Assumption of Risk and I understand that Meadow Run Park reserves the right to alter or amend its rules at any time.
